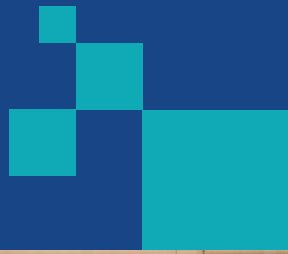

Carole Crawford's diverse career experiences span the investment, finance, and tech industries. She is Managing Partner at fincap360, a global family office consulting firm specializing in venture and niche investments. She often serves as CIO and CFO for families of significant wealth and their related companies, focusing on growth, governance, strategy, succession, and restructuring portfolios. She previously served as Managing Director of the Americas for CFA Institute, leading the largest region globally. Before that, she was Vice President and Senior Consultant at Morgan Stanley, managing client portfolios and launching the SMA and alternatives business in Chicago and Washington DC.

In 2024, Ms. Crawford earned a position on the Forbes 50 over 50 list, which recognizes women creating their greatest impact at 50 or beyond. Ms. Crawford is a former board member of CFA Society of New York and served on CFA Institute's Board of Regents for the Seminar for Global Investors and Capital Markets Policy Council. She previously served on the US Department of Commerce MBDA Family Office Investor Council. In 2020, she received the NYC Fintech Women's Inspiring Fintech Female Leadership Award.

She graduated from the University of Michigan earning a degree in Economics, completed Harvard Business School's Investment Management Workshop, and Wharton School's Certified Investment Management Analyst Program. Ms. Crawford obtained the National Association of Corporate Directors Directorship Certification and is a CFA charterholder.

100WF Hong Kong Foundation Gala Beneficiary



100WF Hong Kong Foundation is a charitable entity focused on the 100 Women in Finance (100WF) mission and Vision 30/40 specifically for the benefit of local Hong Kong based women and girls.

The generous support of our corporate partners and individual donors allows 100WF Hong Kong Foundation to offer complimentary 100WF membership to 500+ university students in Hong Kong.

Additionally, Hong Kong Gala proceeds enable 100WF to develop and produce proprietary programs in Hong Kong, as well as those executed in collaboration with other organizations, to encourage women of all backgrounds to pursue pathways into the finance industry and provide support as they navigate their early career journeys.

Proprietary Programs

JumpStart is a multi-day virtual experience that provides college-age students with an introduction to the financial services industry and the opportunity to meet experienced professionals. Throughout the course of the program, participants receive career guidance, industry information, interviewing and networking tips, and opportunities to interact with professionals, recruiters, and fellow students from around the world. The

program serves as a pre-internship primer and is geared for college-age students at any stage of their career exploration. In Hong Kong the virtual program is supplemented by one-day in-person education events for students, including panel discussions and speed mentoring sessions.



LaunchMe is a mentorship program that helps connect career-ready students to professionals and industry firms. Creating lasting mentoring and advocacy relationships is the final and critical step to welcoming more young women from diverse backgrounds into the industry. LaunchMe is designed to facilitate such introductions and build relationships between career-ready students and current industry leaders.

100 Women in Finance strengthens the global finance industry by empowering women to achieve their professional potential at each career stage. Its members inspire, equip and advocate for a new generation of industry leadership, in which women and men serve as investment professionals and executives, equal in achievement and impact. Through Education, Peer Engagement and Impact, the organization furthers the progress of women who have chosen finance as a career, and enables their positive influence over pre-career young women.



Vision 30/40

We operate under a guiding principle that we call Vision 30/40. It is the goal for women to occupy 30% of senior investment roles and executive committee positions by 2040. Even with our efforts, and those of so many other organizations working towards gender equity, we still have quite a way to go for women to hold even close to the number of investment or executive roles in finance that men currently hold.

Inspired by successful women dedicated to nurturing the next generation, Efsa's story exemplifies how 100WF's initiatives empower pre-career women and strengthen the industry's talent pipeline.



Efsa Aktay is a full scholarship recipient at the University of Hong Kong, where she is studying Finance. Originally from Turkey, she completed her International Baccalaureate diploma before continuing her education in Hong Kong. At HKU, she is working as a Teaching Assistant for a course on applications of AI. Her professional experiences include roles at Adidas, Jardine Schindler and John Swire & Sons where she was seconded to Swire Coca-Cola. These opportunities have given her insights into various business sectors.

Efsa's involvement with 100 Women in Finance began through their Jumpstart program. She participated in the 100WF Investment Hackathon, where she led her team to first place.

Currently, she serves as the APAC representative on the Student Committee for the Launch Me Mentorship Program. Outside of her academic and professional pursuits, Efsa is leading the dragon boat team at her university. She maintains an active lifestyle through hiking and yoga and enjoys reading in her spare time.

CHAMPAGNE Billecart-Salmon, Champagne – FRANCE

Elisabeth Salmon was the current owner's great-great-great grandmother. She was a charismatic and very independent woman for her time. In 1818, she and her husband embarked on an entrepreneurial adventure, creating Maison Billecart-Salmon. From a complex wine, they have succeeded in creating a poetic champagne of great finesse.

CHAMPAGNE Billecart-Salmon BRUT ROSÉ NV

A Romantic Champagne. With its subtle and gourmand aromas, this cuvée provides a reference point amongst rosé champagnes. The production secrets and the vinification method of this cuvée go back to the origins of the House of Billecart-Salmon and have been handed down for seven generations. The Brut Rosé is a blend of Chardonnay, Meunier and Pinot Noir vinified as red wine.

CHAMPAGNE Billecart-Salmon BRUT RESERVE NV

Harmony and balance. A light, fine and harmonious champagne made up of a blend of Pinot Noir, Chardonnay and Meunier from three different years and sourced from the best sites in the Champagne region.

WHITE – Chantal Lescure Cote de Beaune le Clos Des Topes Bizot MONOPOLE 2022 (Chardonnay) Bourgogne – FRANCE

Founded in 1975 by avant-gardist organic producers and true icon Madame Chantal Lescure. This vineyard is fully cultivated in certified organic farming since 2006. The philosophy of the estate and its passionate team is simple, to produce authentic and pure wines, a precise reflection of their terroir.

WHITE – Francois Crochet Sancerre Les Amoureuses 2022 (Sauvignon Blanc) Loire – FRANCE

With François' presence, the vineyard work has become increasingly more sustainable as all vineyards are now certified organic. The vineyards give relatively low yields as the grapes are thoroughly sorted at harvest. The name, Les Amoureuses, translated from French as "the lovers", was given to the wine because of how the rich clay topsoil clings to the boots when the soil is even only slightly wet. This soil makes Les Amoureuses a freight train of Sauvignon Blanc, and the most powerful and generous wine within François' range of white Sancerre.

RED – Chateau Tour de Roch Milon Pauillac AOC 2019 (Merlot, Cabernet Sauvignon) Bordeaux – FRANCE

The vines of Château Tour du Roch-Milon perch on the same gravelly ridge as the legendary Château Mouton Rothschild, one of Bordeaux's 'famous five' First Growths. In fact, their vines share the same vineyard, demarcated only by different coloured stakes at the end of the rows. However, as no official château existed here when Bordeaux properties were classified in 1855, Tour du Roch-Milon did not become a classed growth like its neighbours. This quirk of fate means it's something of a fine wine lover's secret.
