

## TASTING NOTES Liber Wines



LIBER is an independent, privately-owned company dedicated to crafted wines, champagne, and spirits. Our activities are structured around four divisions, each focused on specific customer needs: Agency Distribution, Sommelier Service, Distribution Consulting, and Open Market Sourcing.

#### CHAMPAGNE Billecart-Salmon LE RESERVE NV (served in magnums)

#### Champagne - FRANCE

Formulation: 28% Pinot Noir 29%, Chardonnay, 43% Pinot Meunier

Billecart-Salmon is one of the few Champagne houses to be owned and managed by the original family. Today, Mathieu Roland-Billecart continues the family tradition, hand-crafting delicate and elegant Champagnes. The newly released cuvee "Le Réserve" is a light, fine and balanced champagne. It is a blend comprising 15 vintages sourced from the best sites in the Champagne region. The subtle pleasure of its delicate texture is complemented by a fine vinosity and concentrated aromatics. This wine captivates with its harmonious blend of enticing flavors (apple, crisp pear, and citrus) and roasted notes.

#### **CHAMPAGNE Billecart-Salmon LE ROSE NV**

#### Champagne - FRANCE

Formulation: Pinot Noir, Chardonnay, Pinot Meunier vinified as red wine.

With its subtle and gourmand aromas, this cuvée provides a reference point amongst rosé champagnes. It will bring real pleasure to your happiest moments with its sparkling colour, amazing finesse and great intensity. The production secrets and the vinification method of this

cuvée go back to the origins of the House of Billecart-Salmon and have been handed down for seven generations.

## Chateau Fuisse Pouilly-Fuisse AOC "Tete de Cuvee" 2023 - WHITE (served in magnums)

### Burgundy (Maconnais) - FRANCE

Formulation: 100% Chardonnay

The making and blending of this wine is based on the complementary character in structure and taste of the different terroirs of Pouilly-Fuissé and reflects the different geology of this appellation. These different expressions make the Pouilly-Fuissé Château Fuissé "Tête de Cuvée" into one of the most complete and most typical wines of its appellation.

#### Domaine des Lises Equis Crozes-Hermitage AOC 2021 - RED (served in magnums)

#### **Rhone - FRANCE**

Formulation: 100% Syrah

Exuberant and expressive, every lover of Northern Rhône wines owes it to themselves to pop a hauntingly delicious bottle and be enveloped in the warm embrace of Syrah bliss.



#### Gerard Boulay Sancerre La Cote 750ml 2022 - WHITE

#### Loire - FRANCE

Formulation: 100% Sauvignon Blanc

Gérard Boulay is a renowned French winemaker celebrated for his exceptional Sauvignon Blanc wines from the Sancerre appellation. First crafted in the 2010 vintage, Gerard's old vine parcel in La Cote is one of Boulay's 'blue-blood' historic sites. It produces a wine of incredible precision, power and laser sharp minerality; Boulay's signature style!

## ENTERTAINMENT - COCKTAIL RECEPTION Andrew D'Azevedo





As far back as Andrew D'Azevedo can remember, music has always been a fundamental part of life having begun piano lessons at the age of five with the Yamaha Music School in Sydney, Australia.

By 16, he had achieved his AYMF teaching diploma from Yamaha and A.Mus.A. and L.Mus.A (Dist.) diplomas in piano, certificates awarded by examination to outstanding candidates in the field of musical performance. He was awarded consecutive scholarships with the Sydney Conservatorium's Access Centre (now Open Academy) and learnt with Dutch-Australian classical pianist Gerard Willems. Andrew also picked up cello, playing as part of various chamber groups, the Sydney University Symphony Orchestra and University of Warwick Symphony Orchestra.

He completed final year secondary school exams in music (HSC), receiving a 4th placing in NSW, Australia when he was 15 years old, and was selected to perform at the Sydney Opera House in February 2005.
